SECTION I: INSTRUCTIONS TO BIDDERS

1. Rights of Public Entity

The *LLPBN* reserves the right:

- (a) to split the contract as per the lowest evaluated cost per item, or
- (b) to accept or reject any quotation; and
- (c) to cancel the quotation process and reject all quotations at any time prior to contract award.

2. Preparation of Quotations

You are requested to quote for the items mentioned in Section III by completing, signing and returning:

- (a) the Quotation Letter in Section II with its annex for Bid Securing Declaration;
- (b) the List of Goods and Price Schedule Section III;
- (c) the Specifications and Compliance Sheet in Section V; and
- (d) any other attachment deemed appropriate.

You are advised to carefully read the complete Request for Sealed Quotations document, including the Special Conditions of Contract in Section VII, before preparing your quotation. The standard forms in this document may be retyped for completion but the Bidder is responsible for their accurate reproduction.

3. Validity of Quotations

The Quotation validity period shall be 60 days from the date of submission deadline.

4. Eligibility Criteria

To be eligible to participate in this Quotation exercise, you should:

- a) Should provide two valid reference letters of similar work done not older than two years
- b) The bid Document must be completed in full and each page initialed.
- c) Bidders must provide a sample illustrating the proposed calendar's design if selected. The design and artwork must be original, and while bidders may refer to the previous year's calendar as a guide, they must ensure their submission is distinct. Any design that closely resembles or replicates the previous year's calendar, which is protected by copyright, will be disqualified.

d) The successful Bidder to print the calendar shall forego the copyright of the Artwork and Design to the LLPBN.

- e) Have a valid certified company Registration Certificate/Founding Statement/ Memorandum of Association **MUST BE CORE BUSINESS** (copies that were certified before and recopied and recertified will be rejected);
- f) Have an original valid NamRa good Standing Tax Certificate or certified copy (copies that were certified before and re-copied and recertified will be rejected); (**Should be valid upon bid closing date**)

- g) Have an original valid good Standing Social Security Certificate or certified copy (copies that were certified before and re-copied and recertified will be rejected); (**Should be valid upon bid closing date**)
- h) have a valid certified copy of Affirmative Action Compliance Certificate or confirmation letter from the Employment Equity Commission that the employer did not submit the report for the period following the date when the certificate was issued, proof from Employment Equity Commissioner that bidder is not a relevant employer, or exemption issued in terms of Section 42 of the Affirmative Action Act, 1998;

Quotations should be deposited at the Livestock and Livestock Products Board of Namibia, 38 David Hosea Meroro Rd Windhoek, Operations Department in the foyer in a box marked "TENDER BOX "in a sealed envelope not later than 10 February 2025 @ 12 pm. Quotations should be hand delivered and reach the Livestock and Livestock Products Board of Namibia, 38 David Hosea Meroro Rd Windhoek by the same date and time at latest. Late quotations will be rejected

Quotations received by e-mail will not be considered.

9. Opening of Quotations

Quotations will be opened internally by the LLPBN @ 2pm on 10 February 2025. A record of the Quotation Opening stating the name of the bidders, the amount quoted, the presence or absence of a Bid Securing Declaration will be posted on the LLPBN website as well as on the e-procurement portal within three working days of the Opening

10. Evaluation of Quotations

The LLPBN shall have the right to request for clarifications in writing during evaluation. Offers that are substantially responsive shall be compared based on price and technical compliance. *NB! Lowest priced quotation will not guarantee the awarding of contract.*

11. Technical Compliance

Bidders shall submit along with their quotations documents, catalogues and any other literature to substantiate compliance with the required specifications and to qualify deviations if any with respect to Public Entity's requirements.

The Specifications, Performance Requirements and Compliance Sheet details the minimum specifications of the goods/items to be supplied. The specifications have to be met but no credit will be given for exceeding the specifications.
